Yearly Highlights

The Trust had another blessed year in 2023 – 2024. The capital balance increased and the largest annual grant paid amount was the largest in ACCET's history. The annual return on the investments increased to 9.2%pa. Donations were well down on the previous couple of years, and historically was the lowest annual donation in the Trust's history. However, at the time of writing, some very generous donations were gifted to ACCET to support eveangelistic work in Australia. These donations will appear in the 2024–2025 accounts.

This year saw the addition of a seventh Trustee, Peter Amos from Queensland. Peter is a wonderful addition and blessing to Board. During the financial year, 6 Board Meetings were held: 7 August 2023; 9 October 2023; 3 December 2022; 5 February 2024; 18 March 2024; and 10 June 2024. Two Trustee sub-committees exist, that report into the full Board. These are the *Investment Sub-Committee* and the *Trustee Nomination Sub-Committee*. Each of these sub-committees meet from time to time.

ACCET remains in good shape as it passed the 20 year anniversary on 27 November 2023. The Trustees are so thankful for the individuals and congregations that have donated money over the years. The Trustees work hard to ensure that the donations are soundly invested so that they generate income for grants year after year.

As at 30 June 2024 the asset mix is:

- □ 8.7% in cash, being \$125,438.
- □ 9.2% in direct share holding of a listed investment company, being \$132,068.
- □ 8.7% in an Australian shares index fund, being \$124,712.
- □ 73.5% in a multi asset growth fund, being \$1,058,536
